- Exterior pane of double-pane window broken on north side of the building was from a rock kicked up by the lawn mowing company.
- Another cabinetry disaster. All but one of the upper cabinets in the tech. services room crashed down over the weekend, strewing contents all over the floor. The disc cleaning machine was damaged and the fax machine plug was ripped out of the wall socket. The upper cabinetry in the kitchen went down a few months ago but we thought that was a fluke. Fortunately no employees were present so injury was avoided. Bosben contacted the architect and has an email into the construction company who subcontracted the construction of the cabinetry. Will see if there is any recourse. If not, our great Public Facilities employees are at-the-ready to attempt to repair and re-install the damaged cabinets.
