## **IV.** Building Project

a. **Sprinkler System:** Pam contacted EGI to seek information about the initial flush test. They said the issue should be referred to the plumbing contractor. Pam contacted Prairie Plumbing and they sent documents verifying the test was completed.

Pam believes the Board needs more information from Marquis and suggested he be invited to a future meeting to discuss his ideas. Pam will see if he can attend the January meeting.

- a. Lexington, Kentucky Visit: Tom Wallace, from "Commerce Lexington" (Chamber of Commerce for Lexington, Kentucky) contacted Pam. Every year the membership visits a different city of similar size to theirs. This May they are coming to Madison. Wallace said they'd heard about the Rosemary Garfoot Public Library being the first "green" library in the state. He asked if the library would consider having the group tour the library. He estimated that there would be about 75 people. The Library Board would be pleased to host the tour. Pam did indicate plans were only in the talking stage and Mr. Wallace would be in touch soon to confirm the plans if the group can work it into their schedule. Pam thought this would be a great opportunity to have participation by Village Board trustees.
- **b. Martin Luther King, Jr. Holiday:** Village has given non-union employees this day as a paid holiday. Union employees negotiated the holiday as part of their current contract. Motion, Mike, to have the library follow the Village format and close on Martin Luther King Day/Beth seconded/motion passed.
